## About this document

This document describes the messages deployed in the FINplus service as part of Standards Release 2023.

Deployment pilot future (swift.finplus!pf) – 22<sup>nd</sup> of July 2023

Deployment live (swift.finplus) & Deployment pilot current (swift.finplus!pc) – 19<sup>th</sup> of November 2023

Please note:

- All FINplus messages require RMA to the exception of the tracking (trck) messages where no RMA is required.
- The policy of the FINplus service is to support only one version of a message at any one time in the Live environment. The old version of a message is withdrawn from the FINplus service at the same time as the new version becomes available for live use. There is an exception for the penalties reporting message where the DRAFT4 and DRAFT5 versions of the semt.044 coexist.
